Applicant, and all successors, affiliates, subsidiaries, parent entities, and other related entities (collectively "Applicant") agrees that the extension of credit by Star Rentals shall be subject to and in consideration of the following terms and conditions: **Payment terms are NET 10th (month following date of invoice, payable in U.S. Funds)**, after which date the debt is delinquent.
